This service agreement and contract will remain valid for future service, with the exception of any agreed upon changes in fees, visits and time.

“Business” refers to Happy Scampers, LLC.

The client agrees as follows:

- 1) “Business” and our employees agree to provide services stated in this contract in a reliable and trustworthy manner. In consideration of these services the client expressly waives any and all claims against us or our employees, unless arising from negligence on the part of “Business.”
- 2) “Business” or its employees shall not be held responsible for the loss, injury, death, or actions of any pet that the client has let outside or has instructed the sitter to allow outside while sitter is not there. This includes pets with doggie doors and outdoor pets.
- 3) The client understands that all pets (where appropriate) must have a veterinarian and must have current rabies and other vaccinations.
- 4) All pets with electronic fences must wear their collars with fresh batteries. We are not responsible for any animals that cross the perimeter.
- 5) We do not diagnose, prognose, or make therapy decisions, nor offer veterinary services.
2. Any veterinary/medical concerns will be referred to a veterinarian.
- 6) Understandably, we will not sit for acutely ill animals or those with uncontrolled medical conditions. In those circumstances we suggest the pet be boarded with a vet.
- 7) We cannot accept aggressive animals.
- 8) We will not walk unruly or untrained dogs. If we do agree to walk a pet, all pets must be walked on a leash, no exceptions.
- 9) We will not accept time specific calls, as we cannot guarantee specific times accurately.
- 10) In the event of personal emergency or illness of pet sitter, client authorizes pet sitter to arrange for another qualified person to fulfill responsibilities as set forth in this contract.
- 11) Client understands that contract also serves as invoice and takes full responsibility for prompt payment of fees upon completion of services contracted. In the event it is necessary to initiate collection proceedings, client will be responsible for all attorney’s fees and cost of collection.
- 12) We reserve the right to deny service or terminate service because of safety concerns, financial concerns, or inappropriate or uncomfortable situations.
- 13) We reserve the right to take pet(s) to vet. Client is responsible for all charges.

- 14) In the event of natural disaster, pet sitter is entrusted to use best judgement in caring for pets and home. Pet sitter will be held harmless for consequences or expenses related to such decisions. Every attempt will be made to reach client regarding such situation.
- 15) Payment is expected after services are rendered. A deposit may be required. In the event of additional unforeseen visits or other costs (such as food, supplies, or vet fees), payment is expected within 5 days of the completion of services or a late charge of \$25.00 will be applied.
- 16) Cancellations must be received 24 hours prior to scheduled service or a \$ 25.00 cancellation fee will apply.
